Reporting:

- 1) Budget Leah
 - a) Operating Budget: \$25,491.33
 - i) Flight Fund: \$4,134.93
 - ii) Access to council: \$21,356.40 (money from chip day and hot lunch) Note: This number reflects all the funds received to date, does not include expenses of upcoming hot lunches.
 - iii) Question about how much comes to parent council from chips/lunch?

 A: Chips about \$0.15 or \$0.20 a bag. For hot lunch, varies between \$1.00 to \$0.15 a meal.

2) COSC

- a) ASCA Conference in April
- b) Transportation fees have been a big issue at COSC. If your kids take the bus, there will be an increase in fees.
- c) ATA is not impressed with MLAs, Fridays is Red for Ed, wear red for education. Reach out for MLAs about education, ex new curriculum.

3) Board Report

- a) Board approved 20/21 fees policy.
- b) Participated in budget round table in fort Saskatchewan with the finance minister. Other county council members expressing concerns regarding education.
- c) Board focused on upcoming budget. EIPS lost \$5.5M mid-year gap to be addressed. Reserves used to cover the gap, with little impact to students. The province will continue to only fund to last years budget.
- d) Strategic plan covering how we will make it through the next three years. Growth of 15,000 students annually.
- e) Board to continue debate of Feb 20 transportation meeting.
 - i) Board has wanted to look at a new fee structure
 - ii) One child would pay \$850/yr for school of choice and distance. Family cap is \$945.
 - iii) If you're attending your designated school, and are beyond a distance, the board receives funding as an eligible rider.
 - iv) Provide hazard rides for Ardrossan and fultanvale schools.
 - v) If they only provided the mandated services, EIPS would be running a deficit. (cost of diesel, carbon levy, melt training.)

vi) Fee structure goal is to maintain bus service at this year's level. Fees that are simple and fair for all.

4) Hopitality:

a) Classroom Blessings: Teachers had 80 items on wish lists and 61 of those items were purchased by parents. Parents were frustrated to bring items to the office and would have preferred their children to bring in the gifts themselves.

5) 2020/21

a) Calendar is posted, only one calendar for all of Elk Island. No more ACSI, no more alternative busing days (very labour intensive)
